



# Should I Own My Aircraft in an LLC?

We can form a new LLC in all 50 states, often in as little as 24 hours

If your aircraft is in an accident when others are at the controls, your personal assets are fully exposed to all aircraft liabilities.



## Can't I just get good insurance?

There are many claims that may be excluded from insurance, or accidents that may exceed your policy limits. Ownership of an aircraft as an individual is fine if and only if you are the only pilot. However, when other people fly your same aircraft (even a CFI), you want to protect your personal assets from the other's actions as Pilot in Command. The best way to put a firewall between the two is to own the aircraft in a Limited Liability Company. The LLC should be formed in the same state wherever your aircraft is based more than 50% of the time.

## Can't I just use my regular business attorney?

Maybe, but why take the risk? Operational businesses are not the same as aircraft and should not be treated such. Ask your regular attorney: How does FAR Part 91 differ from Part 135?

## OK, I need this, but how do we structure the LLC?

Who should the members be? What percentages? The answer to this and most legal questions is: "it depends".
